General SECURA Guidelines

Property:

- Building Limit maximum: \$1,000,000
- BPP Limit maximum: \$500,000
- Property deductibles:
 - \$1,000 AOP minimum
 - 1% wind/hail deductible minimum
(flat wind/hail deductibles may be available for some risks)
- Cosmetic Exclusion applies to buildings with metal roofs

Auto:

- \$1,000 comprehensive/\$1,000 collision target deductibles
- \$500 comprehensive/\$500 collision minimum deductibles

SECURA Artisan Contractor Guidelines

Property:

- Building Limit maximum: \$250,000
- BPP Limit maximum: \$100,000
- Property deductibles:
 - \$1,000 AOP minimum
 - 1% wind/hail deductible minimum
(flat wind/hail deductibles may be available for some risks)
- Cosmetic Exclusion applies to buildings with metal roofs

Auto:

- \$1,000 comprehensive/\$1,000 collision target deductibles
- \$500 comprehensive/\$500 collision minimum deductibles
